1. Opening of Meeting 5:30 P.M.

Information: A. Call to Order

The special meeting was convened by Chairman Haynie and held at the Northumberland Courthouse located at 220 Judicial Place, Heathsville, VA 22473.

Motion to ratify Mr. Haynie's approval and to allow Vice Chairman Brann to participate via zoom during the meeting as allowed under the Board's adopted remote participation policy.

2. Budget Presentations

Information A. Greater Reedville Association

Mrs. Shauna McCranie, Executive Director, reminded the Board that the Festival Hall Committee came to the Board in the fall requesting financial support from the County to help restore Festival Hall. She shared some background information about Festival Hall, listing some of the events that have been held there over the years. In 2022, inspections revealed widespread decomposition in the main wood structures that support the flooring so currently the building is not fit for occupancy. Mrs. McCranie expressed her appreciation to the Board for any support they can offer so they can continue to provide the community with this much needed space to host community events and gatherings. She informed the Board that the community at large has raised over \$31,000 for the project with the help of aquapalooza, a mailing to Reedville residents, and the collection of a golf cart raffle.

Supervisor Williams asked what their budget request is.

Mrs. McCranie reminded the Board that they are requesting \$25,000 from the County.

Information: B. Jane Blue - Library Director

Library Director Jane Blue presented the Board with some information related to the services they provide as well as their budget request this year. She stated that the library will receive an increase of \$24,573 in State aid this budget year because the County has faithfully been working their way toward the 67% requirement of revenue coming from the County the library serves. Mrs. Blue explained that at 67% of their operating budget, they should be realizing \$296,874 from the County. This year's request is \$273,515 which will put the library at 58% of the required income from tax revenues in the County. She explained that the request represents a 5% overall funding increase with 3% targeted for salary increases and it allows them to remain competitive with other employers while increasing funds for technology, books, and programs.

Supervisor Williams asked where other counties are in regard to the locality allocation.

Mrs. Blue stated that we are right in the middle. She explained that for a long time Northumberland was at the bottom of that list.

Information: C. Rappahannock Community College

Mrs. Jaimie Tucker, board member representing Northumberland, stated that there are 314 residents in the County attending colleges in the Commonwealth and 157 of them are going to RCC. She thanked the Board for supporting their budget every year. Mrs. Kennedy stated that their budget request is 3% over what they requested last year and thanked the Board for their support. Mrs. Kennedy then shared some stories of what's happening currently at the college.

Information: D. Northern Neck - Middlesex Free Health Clinic

Mr. Graham explained that they've been operating for a little over 30 years and offer a full-time general clinic, medical clinic, and other specialty clinics so patients don't have to travel long distances. He stated that they are continuing to add programs every year, so this year their total budget request is a little over \$2M and he expressed appreciation for all who offer them support.

Information: E. Boys and Girls Club

Ms. Ammons stated that the request from the Boys and Girls Club this year is \$15,000 to support their budget of over \$500,000. She explained that this helps provide training for their staff as well as expand their program to directly impact the member's experience. Mr. Bridges and Ms. Ammons shared some statistics related to the Boys and Girls Club and talked about some of the programs they offer.

Supervisor Long asked if they offer scholarships.

Mr. Bridges stated that they do and if any family needs scholarship help, they can talk to the front desk at any location to discuss scholarship opportunities.

3. County Administrator Items

Action, Information: A. School and County Proposed Budget

Mr. Tadlock stated that the public hearing for the school budget has been held and offered the Board to ask any questions.

Supervisor Long recommended giving the school division a 5% salary increase since this is being considered for County employees. He believes everyone should get the same raise.

County Administrator Tadlock presented a PowerPoint to provide a budget overview for the Board and the public. The full presentation can be accessed in board docs.
