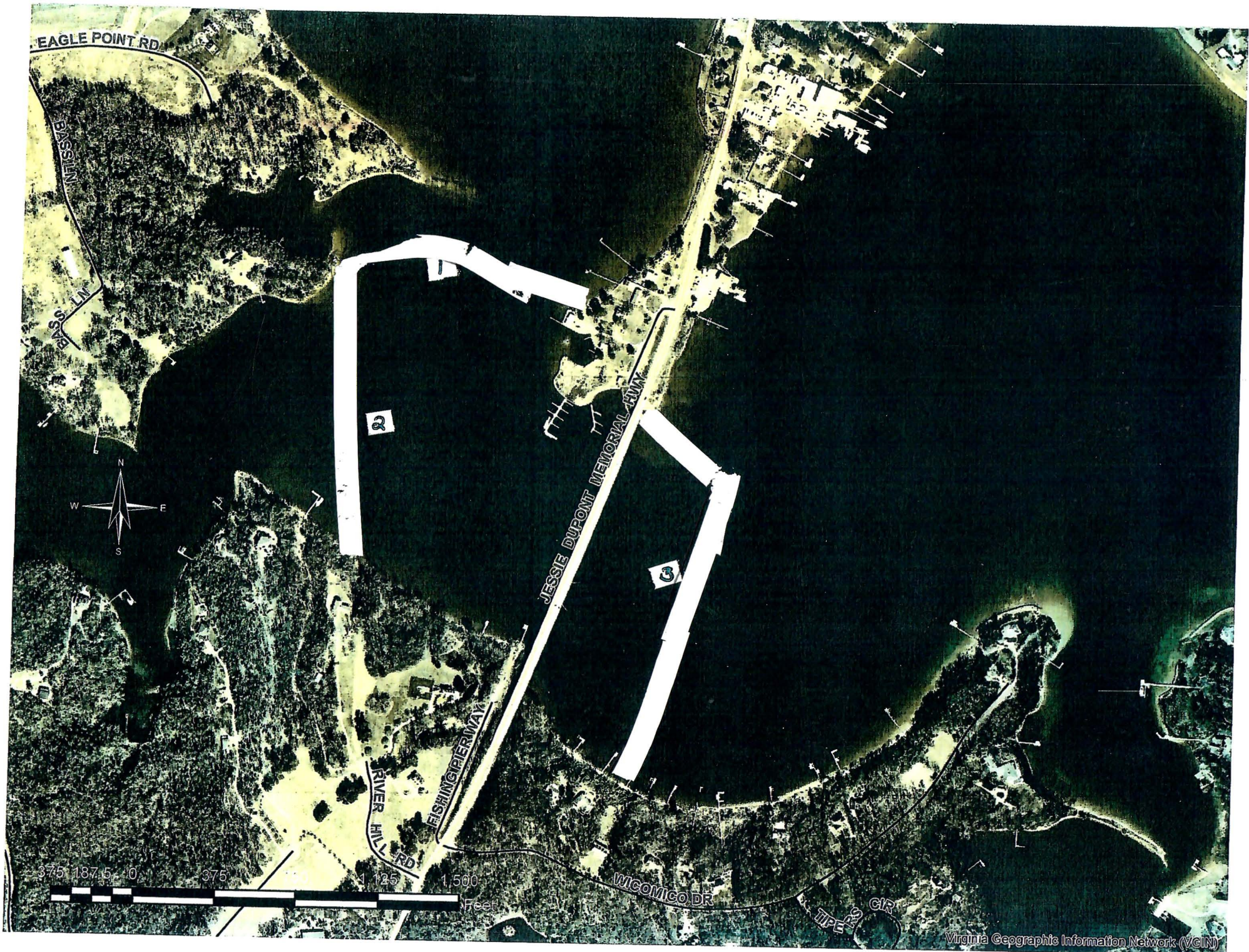

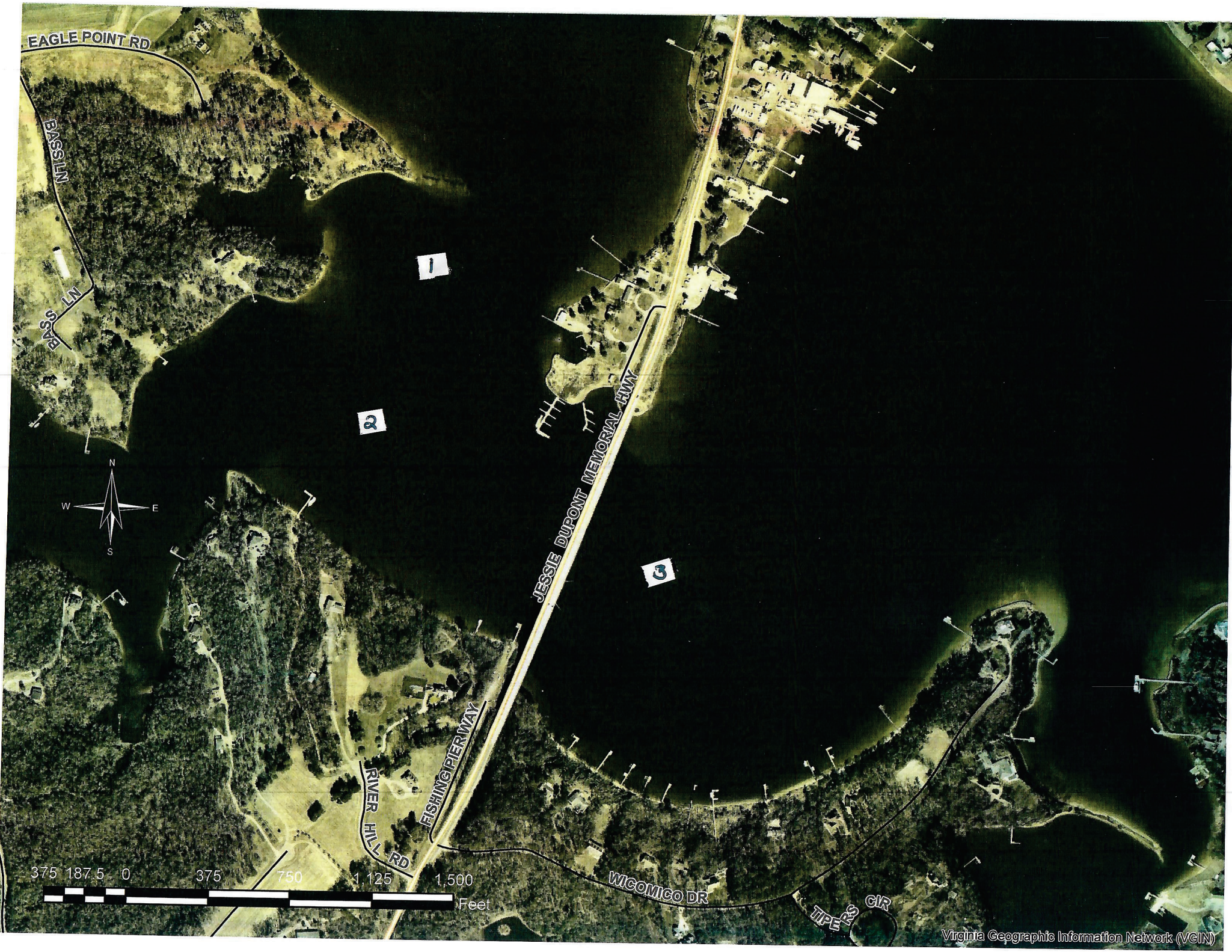
We are permitted for floating upweller systems. We are reluctant to install them, as they will be destroyed by the excessive wake.

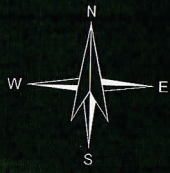
