Board reviewed ballot order with GR; approved the following ballot order for November General Election:

- Three types of ballots required because of Supervisor and School Board election in District 2 and 3.
 - o Type 1: Precincts 1, 4, 5.
 - o Type 2: Precinct 2
 - o Type 3: Precinct 3
- 8300 ballots for Early Voting and Election Day
 - o Type 1: 5200
 - o Type 2: 1700
 - o Type 3: 1400
- 650 folded absentee ballots:
 - o Type 1: 350
 - o Type 2: 200
 - o Type 3: 100

GR reported that all Election Day vDrives were returned to Hart for programming.

Discuss GR plans to staff Early Voting

Board approved GR plans for Early Voting operations.

- Early voting to be in GR office building
- Assistant Registrars will operate the polling place
- GR has selected four Officers of Election to work early voting as needed

Schedule Early Voting Logic and Accuracy testing

EB will conduct L&A testing for Early Voting on September 14, 9:30 AM Will set up four machines: Two each Scanners and TouchWriters

- One Scanner, one TouchWriter for Early Voting
- One Scanner, one TouchWriter spare.

Ms. Carrington had several questions about voter registration; voter list maintenance; election operations; voting machines; and other topics. The General Registrar and EB members answered her questions. Specific questions and responses were:

Question	Response
Concerns about Nov 2020 election and Nov 2021 election?	None.
Last "cleanup" of county voting rolls?	GR and EB described List Maintenance process; provided Ms. Carrington with copy of last Dept of Elections List Maintenance report to General Assembly.
What voting machines does Northumberland County use? How were EB and GR trained on machines? Have COVID restrictions eliminated witness signature for mail-in absentee ballots?	Scanner and TouchWriters from Hart Intercivic; purchased in late 2015/early 2016. Training provided by Hart trainers. Witness signature was waived for Nov 2020 election; witness signatures now required because pandemic restrictions are lifted.
What are security procedures for absentee ballot drop box?	EB shoed ballot drop box at GR office; video surveillance; deputies monitor at night.

Question	Response
What are the procedures for official observers at polling places?	GR and EB described requirements for official observers.
Does Northumberland County use highs school students as pages at polling places?	High school pages were used in 2016 Presidential election; we have not used since. We review the need for pages prior to each election.
Does the Circuit Court Clerk provide to GR a list of non-citizens who were dropped from jury duty?	In fact, the opposite occurs. State Dept of Elections provides list of registered voters to Supreme Court which provides list to Clerks for use in calling people for jury duty. Noncitizens are purged by ELECT before list goes to Supreme Court.
